## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is made between David Marshall King, a United States citizen, residing at 1044 W. Hartley, Ridgecrest, CA 93555, Ronald Brian King, a United States citizen residing at 3405 S. Manito Blvd., Spokane, WA 99203, and Thomas Arnold Martin, a United States citizen, residing at 228 E. Hartley, Ridgecrest, CA 93555, as individuals and as partners comprising the partnership Site-b Company ("Assignor") and Site-b Company, a Washington corporation having a principal place of business at 2920 S. Grand Blvd. #106, Spokane, WA 99203 ("Assignee").

WHEREAS, Assignor owns all right, title, and interest in and to one or more trademarks and service marks ("Marks"), including but not limited to U.S. Trademark Registration No. 2,161,358 filed September 17, 1996, and registered June 2, 1998, for the mark SQUIRREL, and one or more other trademarks and service marks, including those utilized on or in conjunction with packaging, labels, advertisements and other materials associated with the advertising, marketing and selling of one or more mixing devices, and any trademarks/servicemarks comprising trade dress, including packaging and product design, and the goodwill of the business symbolized by the Marks; and

WHEREAS, Assignee is a successor to the entire portion of Assignor's business to which the Marks pertain.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows;

1. Assignor does hereby sell, transfer, assign and otherwise convey to Assignee, its successors and assigns all Assignor's right, title and interest throughout the world, in the following:

(i) the Marks and any renewal thereof;

(ii) the goodwill symbolized by the Marks; and

(iii) the ownership of all causes of action for, and claims for damages by reason of infringement of the Marks, or any of them, which actions arose prior to the date hereof.


2. This Trademark Assignment shall inure to the benefit of, and shall be binding upon, the successors and assigns of the parties.

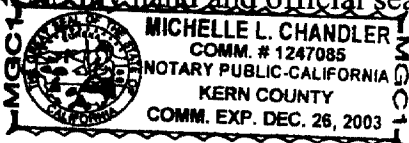




