## TRADEMARK ASSIGNMENT

**WHEREAS**, StarMark, Inc., a South Dakota corporation (“**Assignor**”), located and doing business at 700 East 48th Street North, Sioux Falls, South Dakota, has adopted and used in its business the trademarks (the “**Registered Trademarks**”) that are registered in the United States Patent and Trademark Office under the registration numbers set forth on Schedule A attached hereto, the common law trademarks set forth on Schedule A attached hereto (the “**Common Law Trademarks**”), the trademark applications (the “**Applications**”) that have been filed with the United States Patent and Trademark Office under the serial numbers set forth on Schedule A attached hereto and the foreign trademarks and trademark applications set forth on Schedule A attached hereto (the “**Foreign Trademarks**”) (collectively, the “**Trademarks**”);

**WHEREAS**, Norcraft Companies, L.L.C., a Delaware limited liability company (“**Assignee**”), located and doing business at 3020 Denmark Avenue, Eagan, Minnesota, is desirous of acquiring said Trademarks and the goodwill of the business symbolized by such Trademarks;

**WHEREAS**, Assignor represents and warrants that it has a valid right to license and use and has used the Trademarks and that Assignor has not sold, transferred or otherwise assigned the Trademarks to any third party; and

**WHEREAS**, pursuant to Section 1.1 of that certain Asset Purchase Agreement dated as of March 25, 2002 by and between Assignor, SMI Retail Corp., SMI Transportation, Inc., StarMark of Virginia, Inc., Assignee and Masco Corporation, Assignor agreed to sell, transfer, convey, assign and deliver to Assignee, among other things, rights to the Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:


