The company "MACKIE DESIGNS (ITALY) S.P.A.", also participates in this act in its capacity of successor to universal title of the following companies:

"NOVAC S.R.L." having its registered offices in Milan, in Via Santa Marta no. 12, share capital 4,085,571,000 lira, fully paid up, Milan Company Register no. 1557546/1996, with 11925450154 being its fiscal code and VAT number;

Being sure of the identity of the participant Christopher Scott Campbell, his British citizenship and his swearing to me that he understands the Italian language stipulates the following.

- with the ministerial act prepared by Notary Public Tonelli on December 20, 2000, catalog no. 15.243/7.424, registered at no. 3314 on December 21, 2000 at the Italian Revenue Office in Bologna the companies "NOVAC S.R.L.", "RADIO CINE FORNITURE (R.C.F.)
