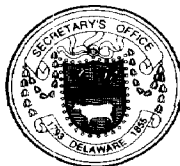

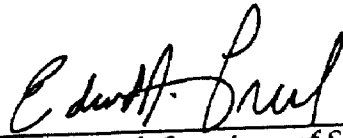

2. The Certificate of Incorporation of the Corporation is hereby amended by deleting Article FIRST as presently constituted in its entirety and adding the following new Article FIRST:

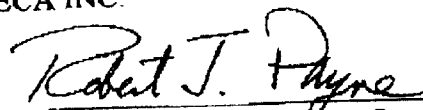
