ASSIGNMENT AGREEMENT

BY AND BETWEEN:

1. Shu Uemura Cosmetics Inc, Japanese company, having its registered office Aoyama Ohara Bldg, 5-7-17 Minami-Aoyama, Minato-ku 107-8803, hereafter called "the Assignor",
2. and L'Oréal S.A., French company having its registered office at 14 rue Royale, 75008 Paris, hereafter called "the Assignee",

WHEREAS:

Assignor wishes to assign and transfer to the Assignee (i) all right, title and interest of Assignor in the trademarks listed on Schedule 1 hereto in all territories of the world other than Japan and France, including the registrations and/or applications (collectively "the International Trademarks"); (ii) all right, title and interest of Assignor in all technology and other intellectual property rights of Assignor used in all territories of the world other than Japan and France (collectively "the International IP"); (iii) all right and interest of Assignor to conduct business outside Japan and France ("the International Market Rights"), and (iv) all agreements covering the said business outside Japan and France unless such agreements are separately assigned and transferred by the Assignor to the Assignee ("the Transferred Agreements"); and Assignee wishes to accept such assignment and transfer according the following terms and conditions.

IT IS MUTUALLY AGREED AS FOLLOWS:

1. The Assignor hereby assigns and transfers to the Assignee, which hereby accepts, all of its right, title and interest in (i) the International Trademarks, (ii) the International IP, (iii) the International Market Rights, and (iv) the Transferred Agreement together with the goodwill of the business associated therewith.
2. The assignment and transfer of (i) the International IP, (ii) the International Market Rights, and (iii) the Transferred Agreement, and the transfer of possession of the International Trademarks shall be effective as of 1st January 2001.
3. The present assignment and transfer is made in consideration of the lump sum payment of 850,000,000 (eight hundred and fifty millions) Japanese Yen, the receipt and sufficiency of which are hereby acknowledged by Assignor.
4. Assignee shall be responsible at its expense of the registration of the present assignment and transfer. The bearer of the present deed is empowered to proceed to the registration of such assignment and transfer.




