RELEASE OF INTELLECTUAL PROPERTY

Release of Intellectual Property (this "Release"), dated as of March 22, 2002, made by Bankers Trust Company, as Collateral Agent ("Collateral Agent"), in favor of Resorts International Hotel and Casino, Inc. (the "Pledgor").

R E C I T A L S :

A. The Pledgor and Collateral Agent entered into a certain Security Agreement, dated as of April 25, 2001 and recorded as to Trademarks with the Trademarks Division of the United States Patent & Trademark Office on June 22, 2001 in Reel 002317, Frame 0475 (the "Agreement"; capitalized terms used herein and not defined shall have the meanings set forth in the Agreement), pursuant to which the Pledgor granted to Collateral Agent a lien on and security interest in certain Pledged Collateral owned by the Pledgor.

B. In accordance with the terms of the Agreement, the Pledgor has satisfied all of its outstanding obligations under the Agreement and, in connection therewith, the Pledgor has requested Collateral Agent to release, and Collateral Agent and the Secured Parties have agreed to release, its lien on all Pledged Collateral pledged pursuant to the Agreement.

A G R E E M E N T :

Collateral Agent hereby releases and terminates all right, title and interest pledged, hypothecated, assigned, transferred, deposited and granted to it by the Pledgor pursuant to the Agreement in all Pledged Collateral, including, without limitation, the Trademarks identified on Schedule I annexed hereto and any reissues, extensions and re-examinations thereof (collectively, the "Released Collateral"), and all liens, security interests, charges or other encumbrances in favor of Collateral Agent in the Released Collateral shall hereby terminate and revert to the Pledgor and all right, title and interest of Collateral Agent in the Released Collateral will hereby cease, terminate and become void.
