BETWEEN:

- (1) **DMA DESIGN LIMITED** whose registered office is at The Green House, 33 Bowdon Street, Sheffield, South Yorkshire S1 4HA (the "Assignor")
- (2) **TAKE-TWO INTERACTIVE SOFTWARE INC.** a Delaware company having an office at 575 Broadway, New York, New York 10012 (the "Assignee")

WHEREAS:

- (A) The Assignor is the proprietor of the trade mark registration, particulars of which are set out in the Schedule attached (the "Trade Mark").
- (B) Following a Development Agreement dated 22 May 1998 between the Assignor, the Assignee and Gremlin Group Plc the Assignor has agreed to assign the Trade Mark to the Assignee on the terms and conditions set out in this Agreement.

NOW IT IS HEREBY AGREED as follows:

1. In consideration of payment of the sum of one pound (£1) by the Assignee to the Assignor (receipt of which is hereby acknowledged) the Assignor hereby assigns and transfers to the Assignee with full title guarantee all property, right, title and interest in and to the Trade Mark, including all common law rights connected therewith and the right to sue for damages and other remedies in respect of any future or any past infringement of the Trade Mark, which may have occurred prior to the date hereof **AND** all the benefit of the Trade Mark **TO HOLD** the same unto the Assignee absolutely, its successors and assigns.
2. The Assignor covenants that it will at the request of the Assignee and at the Assignee's expense execute all documents, papers, forms and authorisations and depose to or swear all declarations or oaths which may be necessary or desirable for securing, completing or absolutely vesting full right, title and interest in and to the Trade Mark in favour of the Assignee.

3. The Assignor hereby warrants that:

3.1 It is the registered proprietor of the Trade Mark and has the full power to enter into this Assignment;

3.2 It has not granted any licences to use the Trade Mark;

3.3 It is not aware of anything which might endanger the validity of the Trade Mark or the ability of the Assignee to register this Assignment.

4. This Assignment shall be governed by and construed in accordance with the laws of England and Wales, and the parties submit to the exclusive jurisdiction of the English Courts.
