## TRADEMARK ASSIGNMENT

**WHEREAS**, ICO, INC. (ASSIGNOR), a Texas corporation, has adopted, used, is using, and is the owner of U.S. Trademark Registration No. 2,182,845, issued August 18, 1998 for the mark ROTOCYCLE; and

**WHEREAS**, WEDCO, INC. ("ASSIGNEE"), a New Jersey corporation, is desirous of obtaining the entire right, title and interest in, to and under the same trademarks and the said applications;

**NOW, THEREFORE**, in consideration of the sum of One Dollar (\$1.00) to the said ASSIGNOR in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, the said ASSIGNOR does hereby sell, assign, transfer and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said trademark registration applications and all trademarks of the United States which may be granted thereon, and all renewals or reissues thereof; and all applications for trademarks which may hereafter be filed for said marks in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said United States application under the Trademark Laws of the United States or any international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; together with the goodwill of the business symbolized by the trademarks and said applications to register said trademarks; and any and all causes of action thereto that may have heretofore accrued in ASSIGNOR's favor.

**AND ASSIGNOR HEREBY** authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue trademarks, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

**AND ASSIGNOR HEREBY** covenant that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.

**AND ASSIGNOR HEREBY** further covenants and agrees that it will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to it respecting said marks, and testify in any legal proceeding, sign all lawful papers, execute all divisions, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper trademark protection for said marks in all countries.
