Pursuant to the provisions of Section 14A:9-2(4) and Section 14A:9-4(3), Corporations, General, of the New Jersey Statutes, the undersigned corporation executes the following Certificate of Amendment to its Certificate of Incorporation:

1. The name of the corporation is CME Acquisition Corp. (the "Corporation").
2. The following amendment to the Certificate of Incorporation was approved by the directors and thereafter duly adopted by the majority of the shareholders of the Corporation as of August 1, 1999.

RESOLVED, that Article FIRST of the Corporation's Certificate of Incorporation is hereby amended to read as follows:

- "1. The name of the corporation is CME Infocom, Inc."
3. The number of shares outstanding at the time of the adoption of the amendment was 1000. The total number of shares entitled to vote on the amendment was 1000
