
**INTELLECTUAL PROPERTY ASSIGNMENT**

IN WITNESS WHEREOF, Big Vision hereby executes this Assignment on this 4 day of April, 2002.

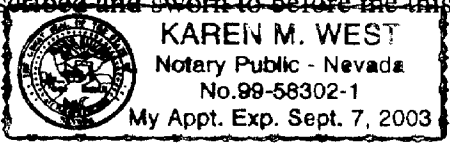
