CONFIRMATION OF TRADEMARK ASSIGNMENT

WHEREAS, on the 29th day of December, 1995, George Shinn Sports, Inc., a North Carolina corporation, (hereinafter, "ASSIGNOR"), and Charlotte Hornets NBA Limited Partnership, a North Carolina limited partnership, having a principal place of business at 100 Hive Drive, Charlotte, North Carolina 28217 (hereinafter, "ASSIGNEE") entered into the Bill of Sale, Assignment and Assumption Agreement, recorded in the Assignment Branch of the United States Patent and Trademark Office on April 22, 1996, under Reel/Frame 1459/0026.

WHEREAS, ASSIGNOR and ASSIGNEE seek to correct the records of the U.S. Patent and Trademark Office to show title in


Registration No. 2017093 and Registration No. 2078370 in the name of the ASSIGNEE.


