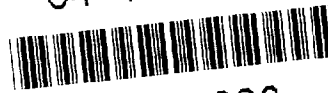

# ASSIGNMENT



This Assignment is made pursuant to the terms of the Agreement.


