Pursuant to the provisions of Section 14A:9-4 of the New Jersey Business Corporation Act, the undersigned corporation adopts this Certificate of Amendment to its Certificate of Incorporation.

Section I. NAME: The name of the corporation is Mycor, Inc.

Section II. DATE OF ADOPTION AND TEXT OF AMENDMENT: The following amendment to the Certificate of Incorporation was adopted by the sole shareholder of the corporation on August 16, 1995.

Article FIRST of the Certificate of Incorporation filed on May 4, 1992 is hereby amended to read as follows:

FIRST: The name of the corporation is:

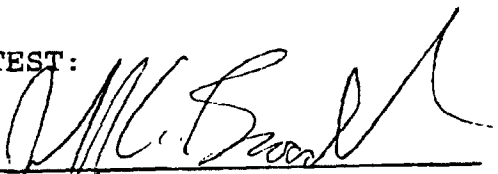
Section IV. ADOPTION BY VOTE: The number of shares that voted for such amendment was one thousand (1,000).
