RELEASE OF TRADEMARK COLLATERAL SECURITY AGREEMENT

This RELEASE is entered into between RANPAK CORP., an Ohio corporation ("Ranpak") and KEYBANK NATIONAL ASSOCIATION, a national banking association ("KeyBank").

Witnesseth:

WHEREAS, Ranpak is the owner of certain trademarks, including, but not limited to, the trademarks set forth on Exhibit A hereto (the "Intellectual Property");

WHEREAS, pursuant to (i) the Amended and Restated Credit Agreement (the "Credit Agreement"), dated as of September 9, 1997, as amended, by and among Ranpak, KeyBank, the other banks named therein and KeyBank as agent for the banks; and (ii) the security agreements and trademark collateral security agreements executed in connection with the Credit Agreement (collectively, the "Intellectual Property Security Agreements") Ranpak granted to KeyBank a continuing security interest in the Intellectual Property;

WHEREAS, the Intellectual Property Security Agreements were recorded with the U.S. Patent and Trademark Office; and

WHEREAS, Ranpak has fully repaid KeyBank and terminated the Credit Agreement, and KeyBank hereby releases and discharges Ranpak from the terms and conditions set forth in the Intellectual Property Security Agreements, and the parties wish to record with the U.S. Patent and Trademark Office the release of the security interest against the Intellectual Property, including, but not limited to, the Intellectual Property set forth in Exhibit A hereto;

NOW, THEREFORE, KeyBank (i) hereby releases all of its security interests in the Intellectual Property, including but not limited to the Intellectual Property set forth in Exhibit A hereto, and hereby transfers and assigns to Ranpak all of its right, title and interest in and to the Intellectual Property; and (ii) has caused this Release to be duly executed this 14 day of JANUARY, 2002.
