Lender's execution or delivery of this instrument does not constitute (a) a waiver or release of any indebtedness or other obligation on the part of Pledgor under any document, instrument or agreement secured by, or described in, the Security Agreement, or (b) a waiver of any (i) default or event of default, or (ii) any right, power, privilege or remedy on the part of Pledgor, under any such document, instrument or agreement.
