WHEREAS, Assignor has agreed to assign and transfer to Assignee any and all right, title and interest owned by Assignor in the Mark, together with the goodwill symbolized thereby.


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, and intending to be legally bound hereby, Assignor agrees as follows:

1. Assignor hereby assigns, transfers, conveys and grants to Assignee any and all right, title, and interest now owned and possessed by Assignor in and to the Mark, including without limitation Registration No. 1,479,552, together with the goodwill symbolized thereby.
2. Assignor further hereby assigns, transfers, conveys, and grants to Assignee all rights of action at law and suits in equity to recover for past infringements of the Mark

currently known to Assignor as of the date hereof or that may become known after the date of this Assignment.

3. This Assignment is being made on an "as is" basis. Assignor expressly disclaims any representations or warranties as to the validity of the Mark, as to Assignor's ownership of the Mark (beyond the presumption under 15 U.S.C. sec. 1057(b) of the Trademark Act created by Assignor's ownership of Registration No. 1,479,552), as to any conflicting rights that any third parties might hold in this Mark or confusingly similar marks or names, and as to any claims, demands, or judgments made against Assignor regarding this Mark.
