
WHEREAS, ASSIGNEE desires to acquire all rights, title, and interest in and to the Trademarks and all business goodwill related therewith;



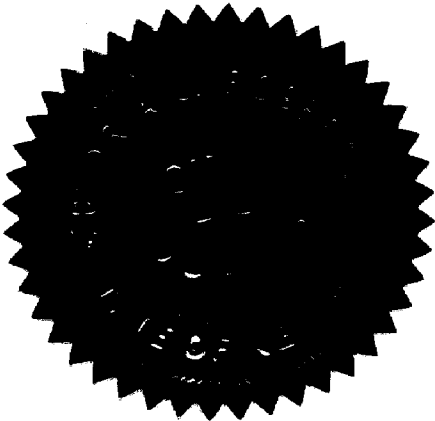
