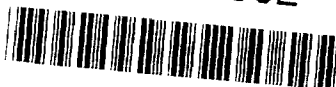

## TRADEMARK ASSIGNMENT





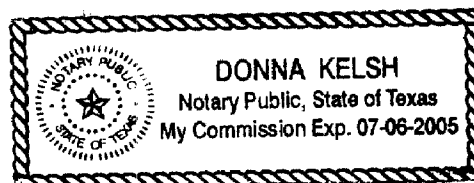
