**NOTICE OF TERMINATION OF SECURITY AGREEMENT**

**THIS NOTICE OF TERMINATION OF SECURITY AGREEMENT** is made by **BANK OF AMERICA, N.A.**, a national banking association, as Agent (the "Agent"), whose address is 101 North Tryon Street, NC1-001-15-04, Charlotte, North Carolina 28255, in favor of **TEAM TIRES PLUS, LTD.**, a Minnesota corporation ("Grantor"), whose address is 2021 Sunnydale Boulevard, Clearwater, Florida 33765.

**WITNESSETH:**

**WHEREAS**, Grantor entered into a certain Security Agreement dated as of July 28, 2000 (the "Security Agreement") with the Agent, for itself and the other "Secured Parties" (as defined in the Security Agreement); and

**WHEREAS**, pursuant to the terms of the Security Agreement, Grantor granted the Secured Parties a security interest in certain registrations with the United States Patent and Trademark Office (the "USPTO") set forth on Exhibit "A" attached hereto (the "Registrations"); and

**WHEREAS**, the Security Agreement has terminated; and


**WHEREAS**, the Agent is giving this Notice of Termination of Security Agreement for the purpose of reassigning of record the Registrations to Grantor;


1. The foregoing recitals are true and correct and are by this reference made an integral part of this Notice of Termination of Security Agreement.
