# REVOCATION OF TRADEMARK ASSIGNMENT

This Revocation of Trademark Assignment (hereinafter the "Revocation") dated this 1st day of April, 2002, is submitted on behalf of the former Interpore International, a California corporation, by its successor in interest, Interpore International, Inc., a Delaware corporation, which has a principal place of business at 181 Technology Drive, Irvine, California 92618.

WHEREAS, a trademark assignment (hereinafter the "Trademark Assignment") was executed on June 23, 2000, and subsequently recorded with the U.S. Patent and Trademark Office on July 10, 2000, entered on Reel #2113, Frame #0756.


WHEREAS, the Trademark Assignment lists the mark **INTERPORE CROSS**, but mistakenly lists the application number for another mark. The erroneous application number, U.S. Serial No. 75/560663, corresponds to Sanford LP's registration for the mark **FREEZE**, U.S. Trademark Registration No. 2287934 (hereinafter the "Registration"). The Registration is outlined in Schedule A, attached hereto and incorporated herein by this reference.

NOW, THEREFORE, because the recorded Trademark Assignment inadvertently listed the application serial number for the mark **FREEZE** rather than the application serial number for the mark **INTERPORE CROSS**, the purpose of the Revocation is to void the Trademark Assignment recorded in connection with the Registration and return all rights, title, and interest in the Registration to the original Registrant, namely, Sanford LP.
