

1. Effective January 7, 2002, The Dime Savings Bank of New York, FSB merged with and into the Association (the "Association Merger"), with the Association as the surviving institution, as evidenced by a Certificate of Merger issued by the Corporate Secretary of the Office of Thrift Supervision, a true and correct copy of which is attached.
2. As a result of the Association Merger, the Association became the sole stockholder of North American Mortgage Company, a Delaware corporation ("NAMCO").
3. I further certify that on January 7, 2002, following the Association Merger, NAMCO executed an Assignment in Liquidation (the "Assignment") following approval by NAMCO's Board of Directors, as evidenced by the Certificate of the then Secretary of NAMCO, a copy of which is attached. Pursuant to the Assignment, NAMCO distributed, assigned, granted, transferred, conveyed and delivered to the Association all of NAMCO's right, title and interest in and to all of its assets.
4. As a result of the Assignment, the Association became the sole and direct owner of all of the assets of NAMCO.
5. On January 28, 2002, North American Mortgage Company was dissolved, as evidenced by the Certificate of Dissolution filed with the Secretary of State of the State of Delaware, a true and correct copy of which is attached.

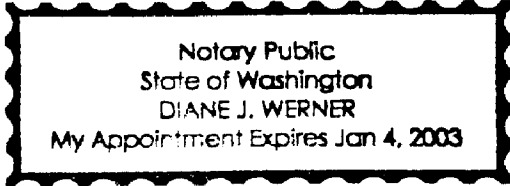



**RESOLVED**, that the Corporation shall hereby be liquidated after the occurrence of both (i) the effective time of the merger of NAMCO Asset Management Inc. into the Corporation and (ii) the effective time of the merger of The Dime Savings Bank of New York, FSB, which is the sole shareholder of record as of the date hereof, into Washington Mutual Bank, FA (the "Association Merger"), and not later than December 31, 2003 and that all the assets of the Corporation (as well as any and all liabilities reflected on the balance sheet of the Corporation) shall be distributed in liquidation to Washington Mutual Bank, FA, which will be the sole shareholder of record upon consummation of the Association Merger, and that such liquidation is intended to be a complete liquidation pursuant to sections 332 and 337 of the Internal Revenue Code of 1986, as amended, and that this consent and the related documentation shall constitute a "plan of liquidation" as that term is used in section 332 of the Internal Revenue Code of 1986, as amended;

**RESOLVED FURTHER** that the board of directors hereby recommends that the shareholder of the Corporation approve the liquidation and the liquidating distribution of assets and that the Chairman and Chief Executive Officer, Chief Operating Officer, Chief Financial Officer, President, the Treasurer, the Executive Vice President and General Counsel, and each of them acting alone, are hereby authorized to take all action necessary or appropriate to notify the shareholder of the recommendation;

**RESOLVED FURTHER**, that upon approval of the liquidation and the liquidating distribution by the Corporation's shareholder, the Chairman and Chief Executive Officer, Chief Operating Officer, Chief Financial Officer, President, the Treasurer, the Executive Vice President and General Counsel, and each of them acting alone, are hereby authorized and instructed to execute any and all documents, to make any and all filings and to take any and all other actions necessary or appropriate to effect the liquidation, and the distribution.



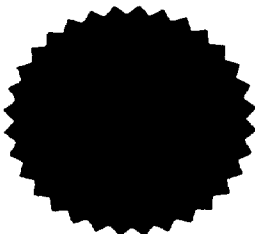


