AND AgriLink hereby requests the official of any jurisdiction where the Trademarks are registered whose duty it is to issue trademark registrations, to issue the Certificate of Registration for any registration resulting from the applications listed on the attached Schedule A to Linden Oaks Corporation, its successors and assigns or other legal representatives, in accordance with the terms of this instrument.


