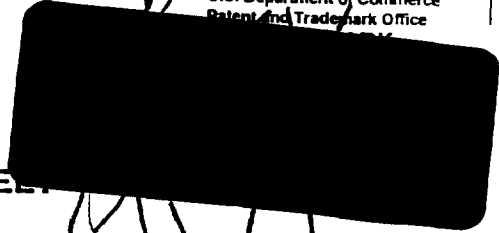

OF CONDITIONAL ASSIGNMENT AND TRADEMARK
SECURITY AGREEMENT**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of **October 23, 2001**, by **First Union National Bank** ("Secured Party").

WHEREAS, the agreement was recorded with the United States Patent and Trademark Office on **April 5, 1999**, at Reel/Frame **1879/0228**; and


WHEREAS, THE Secured Party has agreed to terminate and release its security interest in the Trademarks as herein provided;
