## NUNC PRO TUNC ASSIGNMENT

WHEREAS, Van Dorn Company, formerly known as Van Dorn Iron Works Company, an Ohio corporation with a place of business at 2685 East 79<sup>th</sup> Street, Cleveland, Ohio 44104, ("VAN DORN") had adopted, used and was the owner of the mark VAN DORN<sup>®</sup>, registered with the United States Patent and Trademark Office as Registration No. 730,370, which issued on April 24, 1962.

WHEREAS, it is desired that the Assignment of the VAN DORN<sup>®</sup> registration Nunc Pro Tunc, be made of record in the U.S. Patent and Trademark Office.

Registration to said assignee, CROWN CORK.

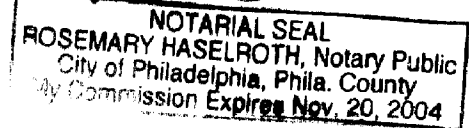

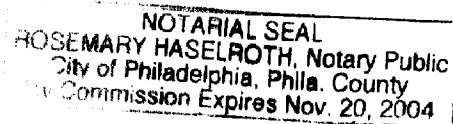
