Trade Mark Assignment

THIS ASSIGNMENT is made the 21<sup>st</sup> day of August 2001

**BETWEEN**

**BAIRD TEXTILE HOLDINGS LIMITED** (company no SC042076) of Granary Building, 1 Canal Wharf, Leeds LS11 5BB, England (the **Assignor**); and

**BMB MENSWEAR LIMITED** (Company number. 4090249) of Granary Building, 1 Canal Wharf, Leeds, LS11 5BB, England (the **Assignee**).

**RECITALS:**

- (A) The Assignor is the proprietor and beneficial owner of the registered trade marks as set out in the schedule ("the Trade Marks").
- (B) Under an Agreement made on 29 November 2000, the Assignor has agreed to assign all of such estate, right, title or interest as it may have in the Trade Marks to the Assignee on the terms set out below.

**NOW IT IS HEREBY AGREED** as follows:-

1 In consideration of the sum of £1 now paid by the Assignee to the Assignor (receipt of which the Assignor acknowledges) the Assignor HEREBY ASSIGNS and transfers to the Assignee with full title guarantee:

- 1.1 all of such estate right title and interest as it may have in the Trade Marks;
- 1.2 all statutory and common law rights and all goodwill attaching to the Trade Marks, and including the right to sue for past infringements and to retain any damages obtained as a result of such action.

**2 GOODWILL**

The Assignor confirms that this Assignment is made with the goodwill attaching to the Trade Marks.

### **3 ASSIGNOR COVENANTS**

The Assignor covenants that it:

- 3.1 will render all necessary assistance and co-operation to give effect to this Assignment and its recordal at the relevant Registries; and
- 3.2 renounces any rights which it may have in respect of the Trade Marks.

### **4 INFRINGEMENT**

- 4.1 Pending the recordal of the Assignee as proprietor of the Trade Marks, the Assignor will lend its name to any proceedings for infringement, including but not limited to trade mark infringement and passing off, which the Assignee may require to be brought against any person wrongfully using the Trade Marks.
- 4.2 The Assignee shall indemnify the Assignor in respect of any costs or other liability arising out of such proceedings.

### **5 JURISDICTION**

This Assignment shall be governed by and construed in accordance with the laws of England and the parties submit to the exclusive jurisdiction of the English courts.
