RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE, dated May 3, 2002 (the "RELEASE") is made by The Bank of Nova Scotia acting in its capacity as secured party (the "SECURED PARTY) under that certain Trademark Security Agreement dated May 20, 1999 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "TRADEMARK SECURITY AGREEMENT") between CHF INDUSTRIES, INC. (the "DEBTOR") and the SECURED PARTY, which TRADEMARK SECURITY AGREEMENT was recorded in the records of the United States Patent and Trademark Office on June 9, 1999 at Reel 001943, Frame 0994.

WHEREAS, pursuant to the TRADEMARK SECURITY AGREEMENT, the DEBTOR granted to the SECURED PARTY a continuing security interest in, among other things, all of DEBTOR's United States trademarks, including its registered trademarks and trademark applications set forth on ATTACHMENT 1 hereto (the "TRADEMARKS");

WHEREAS, the SECURED PARTY wishes to: (i) terminate the TRADEMARK SECURITY AGREEMENT against the TRADEMARKS identified in ATTACHMENT 1 hereto, as recorded with the United States Patent and Trademark Office; (ii) release all of its security interest covering the TRADEMARKS; (iii) restore all right, title and interest in and to the TRADEMARKS to the DEBTOR; and (iv) dissolve any and all liens and encumbrances respecting the TRADEMARKS by SECURED PARTY.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the SECURED PARTY does hereby release its security interest in all of the TRADEMARKS of the DEBTOR, including the TRADEMARKS set forth on ATTACHMENT 1 hereto, and discharges, quit claims and relinquishes unto the DEBTOR (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and to the

TRADEMARKS, and more particularly hereby releases the security interest granted to the SECURED PARTY in the TRADEMARKS which was recorded in the United States Patent and Trademark Office.

IN WITNESS WHEREOF, the SECURED PARTY has caused this RELEASE to be duly executed and delivered by its officer thereunto duly authorized as of the date and year first above written.
