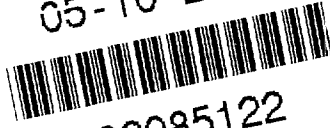

RELEASE OF LIEN AND SECURITY INTEREST

THIS RELEASE OF LIEN AND SECURITY INTEREST ("Release") is made this 14<sup>th</sup> day of July, 1999, by Liberty/FOX KBL, Inc. ("FOX").
