

**RELEASE OF SECURITY INTEREST**

**WHEREAS**, pursuant to the Intellectual Property Security Agreement ("**Security Agreement**") entered into on April 25, 2001, between Integrity Incorporated ("**Integrity**") and LaSalle Bank National Association ("**LaSalle**"), Integrity granted a security interest to LaSalle in certain Copyrights, Patents, Trademarks, and licenses (as defined in the Security Agreement), in the goodwill of Integrity's business connected with and symbolized by the Trademarks, and in all proceeds, indemnities, warranties and guaranties, including all other forms of collateral identified in the Security Agreement (collectively the "**Secured Property**"); and

**WHEREAS**, such Security Agreement was recorded within the records of the United States Patent and Trademark Office at reel 002339, frame 0466; and

**WHEREAS**, on November 2, 2001, Integrity assigned trademark registration number 2,390,830, INTEGRITY WORSHIP MINISTRIES (the "**Mark**") to Integrity Worship Ministries, Inc., an Alabama corporation; and

**WHEREAS**, pursuant to the Security Agreement, LaSalle now desires to release its security interest in the Mark;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, LaSalle does hereby release and forever discharge and reconvey to Integrity all of LaSalle's security interest in Integrity's right, title, and interest in, to and under the Mark, so that it is as if the security interest had never been granted by Integrity; and LaSalle does further acknowledge and affirm that all of the rights and remedies of LaSalle with respect to the security interest and mortgage concerning only this Mark have been and are hereby extinguished; and LaSalle further agrees to perform all additional acts necessary (including executing additional documents) to confirm that LaSalle has no interests of any type in, to, or under the Mark.
