SECOND: An Agreement of Merger, dated as of September
9, 1994 (the "Agreement"), between The MacNeal-Schwendler

certified, executed and acknowledged by each of the above

SEVENTH: MSC has the authority to issue 40,000,000 shares of capital stock, all of said shares consisting of common stock, par value \$0.10 per share.
