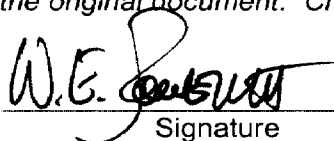

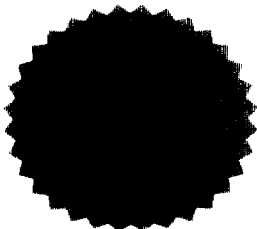

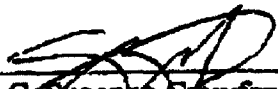
ARTICLE I
