TRADEMARK ASSIGNMENT

WHEREAS, Tradepower (Holdings) Ltd. owned the trademark shown in the chart attached as Exhibit A (the "Mark") and the federal trademark registration therefor; and

WHEREAS, on or about July 19, 1999, Tradepower (Holdings) Ltd. granted an exclusive license to use the Mark in the United States to Academy Corp.; and

WHEREAS, on December 30, 1999 Academy Corp. filed Articles of Conversion with the Texas Secretary of State. These Articles of Conversion were adopted for the purpose of effecting a conversion of Academy Corp., a corporation incorporated under the Texas Business Corporation Act, into Academy, Ltd., a Texas limited partnership. At this time, Academy, Ltd. succeeded to Academy Corp.'s rights and duties under the license; and

WHEREAS, Sportspower acquired by agreement (with an Execution Date of October 26, 2001, and a Recordation Date of November 5, 2001), all right, title and interest in and to the Mark together with the goodwill of the business symbolized by the Mark, any application and registration therefore; and

WHEREAS, Sportspower continued to allow Academy, Ltd. to have an exclusive license to use the Mark in the United States; and

WHEREAS, Academy, Ltd. is currently using the Mark in commerce pursuant to its license agreement with Sportspower; and

WHEREAS, Academy, Ltd.'s use inures to the benefit of Sportspower as owner and licensor of the Mark and the applications related thereto; and

WHEREAS, Academy, Ltd. desires to acquire the Mark;

NOW, THEREFORE, for and in valuable consideration of the payment of Five Thousand and No/100 Dollars (\$5,000.00), the receipt and sufficiency of which is hereby acknowledged, Sportspower does hereby assign unto Academy, Ltd. all right, title and interest in and to the Mark, together with the good will of the business symbolized by the Mark and the application for federal trademark registration related thereto
