

FULL RELEASE UNDER SUBSIDIARY TRADEMARK SECURITY AGREEMENT

WHEREAS, Chattem, Inc. (the "Borrower") is a party to that certain Working Capital Credit Agreement dated August 14, 1991, and that certain Acquisition Credit Agreement dated June 17, 1991, (as amended, modified, or supplemented from time to time, the "Credit Agreements"); and


WHEREAS, Signal Investment & Management Co. (the "Company") is a subsidiary of the Borrower and has guaranteed the obligations of the Borrower under the Credit Agreements; and

WHEREAS, in order to secure the payment, observance and performance of such guaranty obligations, the Company executed in favor of Creditanstalt-Bankverein (the "Agent"), as Agent for the Lenders as such term is defined in the Credit Agreements, a Subsidiary Trademark Security Agreement, dated as of July 1, 1991, (the "Trademark Agreement"), as recorded in the United States Patent and Trademark Office at Reel 798, Frame 146, pursuant to which the Company granted to the Agent, for the benefit of the Lenders, according to the terms of the Trademark Agreement, a security interest in all of its right, title and interest in and to all its marks and the registrations thereof, including, without limitation, the marks listed on Schedule A attached hereto, together with all marks thereafter acquired (the "Marks"), and the use thereof, together with the goodwill of the businesses symbolized by such marks;

WHEREAS, the Company desires to use the Marks to guaranty new obligations, and the Agent, on behalf of the Lenders, desires to release its security interest in the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby release and relinquish to the Company all its right, title and interest in and to the Marks and does hereby agree to the filing of this release in the United States Patent and Trademark Office, with the Trademark Agreement, except as modified herein, to otherwise remain in full force and effect.
