For good and valuable consideration paid by American, the sufficiency of which is hereby acknowledged, Plains does hereby sell, assign, and transfer unto American, its successors and assigns, the entire right, title, and interest it may have, in and to said Marks, effective as of the date this Assignment is executed as indicated below, together with the goodwill of the business symbolized by said Marks, which sale, assignment, and transfer includes any and all past and present rights and powers, statutory and common law, which may have accrued or may accrue to Plains, of any and all kind or nature appertaining to said Marks, the same to be held and enjoyed by American and for the use and benefit of its successors and assigns as fully and entirely as the same would have been held by Plains, had such sale, assignment, and transfer not been made.
