TRADEMARK ASSIGNMENT AGREEMENT

WITNESSETH

Whereas, Assignor has adopted and used and is the owner of the service mark **cozone.com** as shown in U.S. Application No. 75/848074 (the "Mark");


Whereas, Assignor has agreed to assign and Assignee has agreed to acquire all of Assignor's right, title and interest in and to the Mark, both registered and common law, the goodwill of the business symbolized thereby, and the right to recover damages and profits for past infringement thereof; and

Now, therefore, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers and conveys unto Assignee all of Assignor's right, title and interest in and to the Mark, both registered and common law, the goodwill of the business symbolized thereby, and the right to recover damages and profits for past infringement thereof.
2. This Agreement shall be governed by and construed in accordance with the laws of the United States of America and the State of Texas.
