WHEREAS, it is now desirable to memorialize the assignment in a form suitable for recording in the United States Patent and Trademark Office.



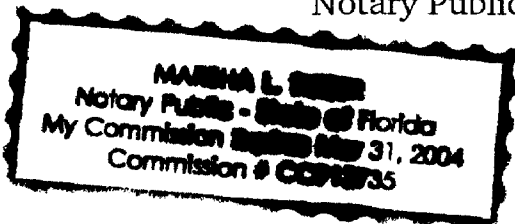
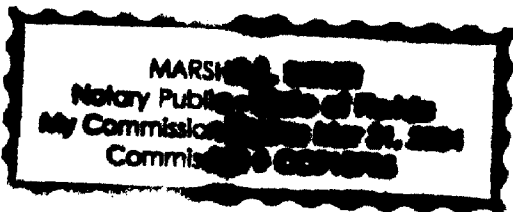
