ACKNOWLEDGMENT OF ASSIGNMENT

Box 39040, Solon, Ohio 44139 (hereinafter referred to as CGI), hereby ratify and acknowledge the prior assignment of the IQPLUS (stylized) trademark as set forth herein.


MATO represents and warrants to CGI that MATO, as joint owner with CGI, adopted and used a trademark IQPLUS (stylized), for price quotations regarding the cost of materials and installation of insulation of metal buildings, which is registered on the Principal Register of the United States Patent and Trademark Office as Registration No. 1,976,361, registered May 28, 1996.

For good and valuable consideration, the receipt of which is hereby acknowledged, MATO does hereby acknowledge that it granted and assigned unto CGI all right, title, and interest in and to the trademark IQPLUS (stylized) for price quotations regarding the cost of materials and installation of insulation of metal buildings including all common law rights thereto and the said federal registration No. 1,976,361 thereto, together with the goodwill of the business associated with and symbolized by the trademark including the right to sue and recover damages and profits for past infringement.
