TRADEMARK ASSIGNMENT

WHEREAS, AMERICAN GLASSMITH, INC., a Delaware Corporation, ("Assignor"), hereby does assign, transfer, grant, and pledge to ARCH OHIO, INC. ("Assignee"), a Florida corporation, the entire right, title, and interest in and to each of the trademarks, trademark registrations, and applications therefor listed on the attached Exhibit A (collectively, the "Trademark Rights"), and any and all rights and privileges provided under the trademark, common, and other laws of the United States, the individual states thereof, and jurisdictions foreign thereto with respect to the foregoing; the GOODWILL of the business in which the Trademark Rights are used and the GOODWILL as represented by such Trademark Rights; and any and all renewals thereof, including the right to claim priority in all jurisdictions based on the Trademark Rights, the same to be held and enjoyed by Assignee to the full end of the terms for which the Trademark Rights are granted, as fully and entirely as the same could have been held and enjoyed by Assignor if this assignment and sale had not been made, together with all rights of action for past infringement;

WHEREAS, Assignee is a successor to the business, assets and appurtenant goodwill of Assignor to which the Trademark Rights pertain, and the parties acknowledge that the business of Assignor was, at the time of the assignment, transfer, grant, and pledge ongoing and existing as required under 15 U.S.C. § 1060;

NOW, THEREFORE, in view of the payment of Ten Dollars and 00/100 (\$10.00) and other legally sufficient and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignor, Assignor DOES HEREBY assign, transfer, grant, and pledge to Assignee, any and all right, title and interest in and to the Trademark Rights; all rights and privileges provided under the trademark and other laws of the United States, the individual states thereof, and jurisdictions foreign thereto with respect to the foregoing; the GOODWILL of the business in which the marks are used; and any and all renewals thereof, including the right to claim priority in all jurisdictions based on the Trademark Rights, the same to be held and enjoyed by Assignee to the full end of the terms for which the Trademark Rights are granted, as fully and entirely as the same could have been held

and enjoyed by Assignor if this assignment and sale had not been made, together with all rights of action for past infringement.

Assignor shall, without further consideration, execute any and all additional documents and take such further action as may be reasonably requested by Assignee to vest in Assignee good, valid, and marketable title to the Trademark Rights.

This Assignment and all terms hereof shall be binding upon and inure to the benefit of the parties and their respective heirs, personal and legal representatives, successors, and assigns.
