COLLATERAL ASSIGNMENT OF MARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Shorty's World, Inc., a New Hampshire corporation, with a place of business at 230 Route 101 West, Bedford, New Hampshire 03110 (the "Assignor") hereby assigns and grants to Citizens Bank New Hampshire with a place of business at 875 Elm Street, Manchester, New Hampshire 03101 (the "Lender"), a security interest in and to all of the rights, title and interest of the Guarantor in and to (i) the trademarks, service marks, trademark registrations, service mark registrations, trade names, collective marks and certification marks and trademark and service mark applications, and trade dress, including logos and/or designs, in connection with any of the foregoing as set forth on Schedule A hereto, (ii) all renewals of any of the foregoing, (iii) all income, royalties, damages and payments now or hereafter due and/or payable under any of the foregoing or with respect to any of the foregoing, including without limitation, damages or payments for past or future infringements of any of the foregoing, (iv) the right to sue for past, present and future infringements of any of the foregoing, (v) all rights corresponding to any of the foregoing throughout the world, and (vi) the goodwill of the Guarantor's business connected with and symbolized by any of the foregoing (collectively, the "Marks").

Until and unless there shall exist an Event of Default under the Security Agreement (as defined below) and the Lender has given notice to the Assignor of the Lender's intention to exercise its rights under the Security Agreement, the Lender hereby grants to the Assignor, without representation or warranty by the Lender, the exclusive, nontransferable right and license (i) to use the Marks on and in connection with goods and services sold by the Assignor, for the Assignor's own benefit and account and for none other and (ii) to collect any and all royalties under any sublicenses granted by the Assignor.

This Collateral Assignment is made pursuant to, and to further secure the satisfactory performance of all of the Secured Obligations as such term is defined in, that certain Security Agreement (Intellectual Property) dated as of April 30, 1998, and amended by amendments dated as of March 17, 2000, December 29, 2000, and November 14th, 2001, by and between the Assignor and the Lender, as the same may from time to time hereafter be amended and in effect (the "Security Agreement").
