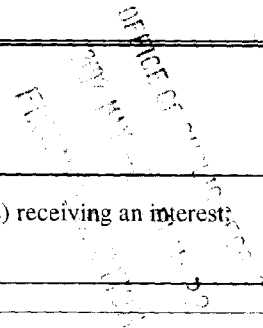

DEED OF ASSIGNMENT

THIS DEED is made the 8th day of March. Two Thousand and Two
BETWEEN Pratt Burnerd International Limited, a corporation of the United Kingdom with an

contained herein


NOW THIS DEED WITNESSETH as follows


