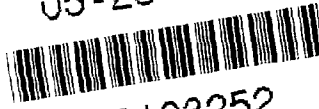

## PATENT AND TRADEMARK SECURITY INTEREST RELEASE

THIS PATENT AND TRADEMARK SECURITY INTEREST RELEASE is effective as of the 29<sup>th</sup> day of April, 2002, by Titus Interactive S.A. (“**Titus**”).

WHEREAS, Titus has a security interest of record in the trademarks listed in Exhibit A, and in certain other patents, patent applications and trademark applications, all of which were identified as exhibits to that certain Assignment for Security of Patents, Trademarks and Copyrights dated April 14, 2000 (the “Security Agreement”) and recorded in the United States Patent and Trademark Office on Reel 002109, Frames 0797-0811;

WHEREAS, at the time the security interest was recorded, the patents, patent applications, and trademark applications, and the trademarks of Exhibit A were in the name of Interplay Entertainment Corp. (“**Interplay**”) and/or Shiny Entertainment, Inc., a wholly owned subsidiary of Interplay (“**Shiny**”);

WHEREAS, such patents, patent applications, trademark applications and trademarks were pledged as collateral under the Security Agreement;

AND WHEREAS, Interplay has satisfied its obligations under said Security Agreement and desires to have the security interest of Titus released.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Titus agrees to release its security interest in any patents, patent applications, and trademark applications of Interplay and Shiny, and in the trademarks listed in Exhibit A and Titus hereby (including all goodwill associated therewith):

Grants, reassigns and conveys to Interplay its entire right, title and interest in and to any and all patents, patent applications, and trademark applications of Interplay and Shiny, and to the trademarks listed in Exhibit A (including all goodwill associated therewith), including without limitation its security interest in the foregoing, the right to sue for past, present and future infringements of such patents, patent applications, trademark applications, and trademarks (including all goodwill associated therewith), all rights corresponding thereto throughout the world, and all renewals and extension thereof, as if the Security Agreement entered into on April 14, 2000 never occurred.

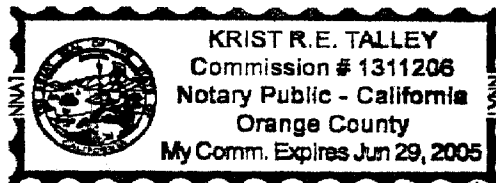
