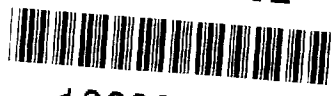

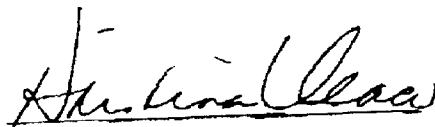
1. That Article FIRST of the Corporation's Certificate of Incorporation is
