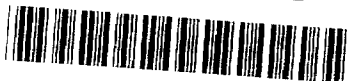

ASSIGNMENT OF TRADEMARKS

ASSIGNMENT OF TRADEMARKS (the "Assignment") made as of May 3, 2002, 2002, by Cooperative Resource Services, Ltd., an Ohio limited liability company having a principal place of business at 6070 Parkland Boulevard, Mayfield Heights, OH 44124 ("Assignor"), to SIRVA Acquisition Company, LLC, a Delaware limited liability company having its principal place of business c/o SIRVA, Inc. at 215 W. Diehl Road, Naperville, IL 60563 ("Assignee").

WHEREAS, Assignor owns and uses the marks set forth on Schedule A hereto and incorporated by reference herein, certain of which are registered in, or for which application for registration has been filed in the United States Patent and Trademark Office (such marks, registrations and applications, together with any and all common law rights pertaining thereto, are referred to collectively as the "Assigned Marks");

WHEREAS, Assignor, Assignee, SIRVA, Inc., Edward J. Davidson and certain other persons are parties to that certain Purchase Agreement, dated as of March 19, 2002, as amended (the "Purchase Agreement"), pursuant to which Assignee is purchasing the Acquired Business from Assignor, and in connection with which Assignor has used the Assigned Marks (capitalized terms used herein without definition shall be used as defined in the Purchase Agreement);

WHEREAS, pursuant to the Purchase Agreement, Assignor has agreed to assign all of Assignor's right, title and interest in and to the Assigned Marks to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

Assignor does hereby sell, transfer, convey, assign and deliver to Assignee all right, title and interest of Assignor in and to the Assigned Marks, the registrations and applications for registrations thereof, and the goodwill of the business connected with the use thereof and symbolized thereby free from any Liens, other than Permitted Liens; all rights of priority therein in any country as may now or hereafter be granted to Assignor by law, treaty or other international convention; and all rights, interests, claims and demands recoverable in law or equity, that Assignor has or may have in profits and damages for past, present and future infringements of the Assigned Marks, including, without limitation, the right to compromise, sue for and collect such profits and damages; the same to be held and enjoyed by Assignee, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

All representations and warranties from Assignor to Assignee in the Purchase Agreement with respect to the Assigned Marks and the other rights assigned above are incorporated herein by reference.

Assignor hereby agrees that Assignor and the Founder will, from time to time, execute and deliver to Assignee such additional instruments, documents, conveyances or assurances and take such other actions, as may be necessary, or otherwise reasonably requested by Assignee, to confirm and assure the rights and obligations provided for hereunder and in the Purchase Agreement and render effective the consummation of the transactions contemplated hereby and thereby.

This Assignment shall be governed by, and construed in accordance with, the laws of the United States, in respect to trademark issues and in all other respects including as to validity, interpretation and effect by the laws of the State of New York, without giving effect to its principles or rules of conflict of laws to the extent such principles or rules are not mandatorily applicable by statute and would require or permit the application of the laws of another jurisdiction.
