

ARTICLES OF AMENDMENT

THIS IS TO CERTIFY

FIRST: That the Charter of Sweetheart Properties, Inc., a Maryland corporation, having its principal office in the County of Baltimore, Maryland (hereinafter called the "Corporation"), is hereby amended by striking out Article SECOND of the Articles of Incorporation and inserting in lieu thereof the following:
