**TRADEMARK SECURITY AGREEMENT
FOR RECORDATION**

WHEREAS, AMERICAN MEDICAL ALERT CORP., a New York corporation (the "Company"), having its principal place of business at 3265 Lawson Boulevard, Oceanside, New York 11572 is the owner of all right, title and interest in and to the United States trademarks set forth on Schedule A attached hereto;

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreement dated May 20, 2002 (the "Trademark Agreement") made by Company in favor of **THE BANK OF NEW YORK**, a New York banking corporation ("Secured Party"), the Company is required to grant a security interest in, and lien on, said trademarks to secure the obligations of the Company under a Credit Agreement, dated as of May 20, 2002 between the Company and the Secured Party; and


WHEREAS, Company is willing to grant to Secured Party the security interest in and lien on the trademarks described above.
