

**RELEASE OF SECURITY**

This **RELEASE OF SECURITY** dated May 15, 2000 (this "Release") is entered into by and between each entity identified on Schedule I annexed hereto (each, a "Grantor"), and Credit Agricole Indosuez (formerly Banque Indosuez), as security agent for and representative of (in such capacity herein called "Secured Party") the financial institutions ("Combined Senior Lenders") party to the Omni AXEL Facility Agreement, the Finobling Facilities Agreement and the Revolving Credit Facility Agreement and the financial institutions ("Mezzanine Lenders") party to the Mezzanine Facilities Agreement. Reference is made to that certain Trademark Security Agreement dated as of January 31, 1997 (recorded in favor of the Secured Party in the United States Patent and Trademark Office on February 12, 1997 on reel no. 1555 and frame no. 0565) in relation to the trademark records listed in Schedule 2 hereof (the "Trademark Security Agreement"). For good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Secured Party hereby notifies, acknowledges to and agrees with the Grantors that, subject to the terms hereof, Secured Party hereby releases and forever discharges and reconveys to the Grantors all of its right, title or interest of any kind or nature granted, assigned or conveyed by the Grantors pursuant to the Trademark Security Agreement in the trademarks listed in Schedule 2 hereof, including all re-issues divisions, continuations, renewals, extensions and continuations in-part thereof (the "Released Trademarks") and Secured Party acknowledges and affirms that all of its rights and interests in the Released Trademarks (including, without limitation, the right (but not the obligation) to sue for past, present and future infringements in the name of Grantor or in the name of the Security Agent, the Combined Senior Lenders and/or the Mezzanine Lenders) are hereby extinguished.
