MEMORANDUM OF ASSIGNMENT

WHEREAS, by a Property Transfer Agreement dated April 2, 1993 (the "Prior Assignment"), Ball Corporation, an Indiana corporation, assigned to Alltrista Corporation, an Indiana corporation, all of its right, title and interest in the trademark YORKER and its U.S. Registration No. 946,928, registered November 7, 1972, and the trademark  and its U.S. Registration No. 946,929, registered November 7, 1972 (referred to herein collectively as the "YORKER TRADEMARKS"), together with the goodwill of the business symbolized by the YORKER TRADEMARKS and in connection with which each of the YORKER TRADEMARKS has been used;

WHEREAS, Ball Corporation and Alltrista Corporation wish the assignment records of the U.S. Patent and Trademark Office to correctly indicate that Alltrista Corporation is the owner of all right, title and interest in the YORKER TRADEMARKS, including the goodwill symbolized by the YORKER TRADEMARKS;

NOW, THEREFORE, for good and valuable consideration which has been received by Ball Corporation from Alltrista Corporation and in accordance with the Prior Assignment, Ball Corporation hereby confirms its prior assignment of, and assigns for the record, all right, title and interest in the YORKER TRADEMARKS, that is, U.S. Trademark Registration No. 949,928, registered November 7, 1972, and U.S. Trademark Registration No. 949,929, registered November 7, 1972, together with all of the goodwill symbolized by the YORKER TRADEMARKS and the registrations identified above.
