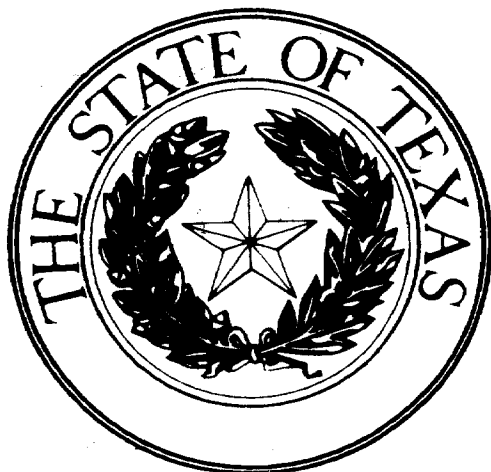

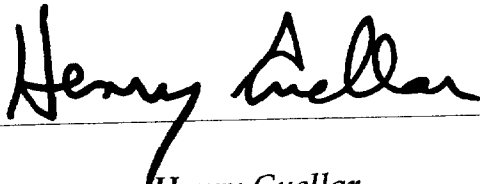

Pursuant to the provisions of Chapter 92A of the Nevada Revised Statutes, the corporations herein named do hereby certify the following:

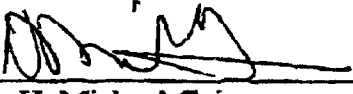

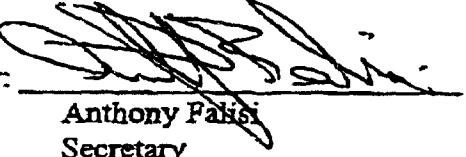
