2. by a merger agreement of November 29, 1999 Krups GmbH at Solingen has been merged by transferring its assets in their entirety together with all rights and duties into the acquiring MxK Moulinex GmbH at Cologne according to sec. 2 (1) lit. 1 of the Reorganization Act without liquidation (merger by takeover) and the merger has become effective upon entry into the Commercial Register of MxK Moulinex GmbH on February 28, 2000,



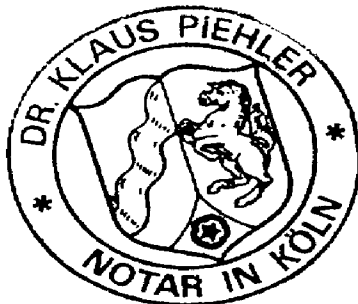
