ASSIGNMENT OF TRADEMARKS




In consideration of entering into the Purchase Agreement, dated as of the date hereof, and other valuable and lawful consideration, the receipt of which from Buyer is hereby acknowledged by Company, Company does hereby:

Sell, assign, and transfer to Buyer the Company's entire U.S. and foreign right, title and interest in and to the registrations for said Marks and all of its right, title and interest to said Marks not presently registered set forth in Schedule A hereof, together with the goodwill of the business symbolized by the Marks and the registrations thereof, and all other rights which Company has enjoyed thereunder both in the United States and throughout all countries of the world, including any and all rights of recovery based on past infringement of said Marks and/or registrations, the same to be held and enjoyed by the Buyer, its successor and assigns, forever and to the full end of the terms for which any of the aforesaid Marks are registered and any renewals of the terms thereof,

And for the same consideration, the Company hereby covenants and agrees to and with the Buyer, its successors, legal representatives and assigns, that the Company will, whenever counsel of the Buyer, or the counsel of its successors, legal representatives and assigns, shall advise that it is lawful and desirable, sign all papers and documents, deliver necessary documents including original registration certificates, if available, take all lawful oaths, execute separate confirmatory assignments, and do all acts necessary or desirable to be done for the procurement, maintenance, enforcement and defense of said Marks and registrations thereof without charge to Buyer, its successors, legal representative and assigns, but a the cost and expense of the Buyer, its successors, legal representatives and assigns.
