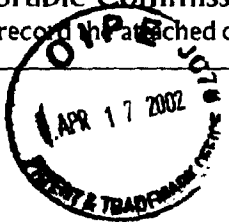



Select Medical Corporation ("Select"), a corporation organized under the laws of Delaware, hereby requests, as assignee, that the release of security interest recorded at Reel/Frame No. 2394/0847 in the records of the Assignment Branch of the U.S. Patent and Trademark Office ("PTO") be **nullified** as a transaction that should not have taken place. The release of the security interest by Chase Manhattan Bank ("Chase") to Select was based upon an assignment of security interest to Chase by Select, originally recorded on Reel/Frame No. 2159/0938. The assignment of security interest to Chase was the result of an error in that Select did not own the subject registration at the time of the transaction. 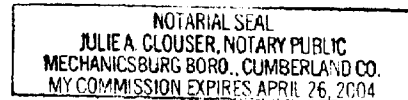

